

F-1 or M-1 International Student Statement of Finances

Please read the following prior to completing this form:

The purpose of the *Statement of Finances* is to help Meridian Community College obtain complete and accurate information about the funds available to international applicants who wish to study at the institution. Strict government regulations require Meridian Community College to verify the financial resources of each international applicant prior to issuance of the Form I-20. Students are required to provide evidence of funds in the amount of at least **\$15,942.00 (IN US DOLLARS)**. Students must have a plan to support themselves during their entire length of study. All fees are based on estimated annual costs and are subject to change at any time. On-campus employment is not guaranteed and should not be seen as a significant means of support while at the college. Arrangements should be made to have funds available at the time of registration for each semester. At least half the cost of tuition and fees for a student's first semester is due on or before the first day of class.
